Cornerstone Natural Resources LLC is now offering direct deposit, also called Automated Clearing House (ACH), for revenue royalty checks. The purpose of this letter is to invite you to enroll in direct deposit.

**Why should YOU enroll in direct deposit?**

- Owners enrolled in direct deposit typically receive their monthly revenue within 1-2 business days after Cornerstone has distributed revenues. Manual checks are delivered through the US Postal Service, which can take up to a week or longer for delivery.
- On-line statements are convenient, and direct deposit eliminates lost checks and minimize fraud.
- The ability to receive revenue check detail electronically using EnergyLink, a software service that facilitates the exchange of data for the energy industry via a cloud-based Electronic Data Interchange. Learn more about EnergyLink at [www.energylink.com](http://www.energylink.com).

**If I enroll in direct deposit, how will I receive my monthly revenue check detail?**

- You will be able to access your revenue details on a secure website called [www.energylink.com](http://www.energylink.com). It is a **FREE** service for you to view and print your statements.
- To self-register you will need to visit: [www.energylink.com/Public/Signup](http://www.energylink.com/Public/Signup) to complete the activation for your EnergyLink account.
- You will need to following information handy when you complete your registration:
  - Company/Individual/Owner Name
  - Oil and Gas Operator Company Name
  - Owner # with Operator
  - Address on file with Operator
  - Check number, corresponding date, and amount
- After registering with EnergyLink, you will automatically receive an email each month with a pdf copy of your statement. You can also sign into your account and download the .pdf for free as well.

**How do I enroll?**

- To enroll in the program, simply fill out the enclosed form and return the executed original enrollment form to Cornerstone by mail along with a voided check from your designated bank account or account verification letter (signed by a bank representative) from your bank.
